Michael L. Kuchera, DO, FAAO graduated from the Kirksville College of Osteopathic Medicine (KCOM) in 1980. After postdoctoral training at Richmond Heights General Hospital and the Cleveland Clinic Foundation (neuroelectrodiagnostics fellowship), Dr. Kuchera was employed at KCOM for 21 years holding various positions including Department Chairperson of the Department of Osteopathic Manipulative Medicine (OMM), Vice President of International Osteopathic Medical Education & Research, and Vice President for Academic Affairs & Dean. Currently he is a tenured professor in the OMM Department at the Philadelphia College of Osteopathic Medicine (PCOM) where he directs the Human Performance & Biomechanics



Research Lab, OMM research, and the neuromusculoskeletal sciences masters level track. At PCOM, he is also clinical director of the Center for Chronic Disorders of Aging [an Osteopathic Heritage Foundation Center].

Dr. Kuchera is a past-president of the American Academy of Osteopathy (AAO); a founding member and former chairperson of the Council (now Bureau) for International Osteopathic Medical Education & Affairs; and multi-decade member of the AOA Council on Research (chairing the Grants Review Committee). Currently retaining membership on all of these groups, Dr. Mike is also the chairperson of the AAO International Affairs Committee and Secretary-General of the Fédération Internationale de Médecine Manuelle.

Dr. Mike has co-authored four standard osteopathic textbooks; published scores of osteopathic abstracts and journal articles; and written multiple chapters in the first 3 editions of the Foundations of Osteopathic Medicine. With several grant awards, he is actively researching the role of nitric oxide in osteopathic techniques such as lymphatic pedal pump; measurable changes in hysteresis after the use of OMT to correct somatic dysfunction; interexaminer reliability of various osteopathic palpatory tests; and the effects of OMT in clinical conditions such as hypertension, fibromyalgia syndrome and multiple sclerosis.
